The College Illinois!® 529 DAY FREE COLLEGE SEMESTER SWEEPSTAKES is administered and sponsored by College Illinois!® and the Illinois Student Assistance Commission ("ISAC"), located at 1755 Lake Cook Road, Deerfield, IL 60015-5209.

NO PURCHASE IS NECESSARY TO ENTER OR TO WIN THE PRIZE. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCE OF WINNING. PRIZES FOR THE COLLEGE ILLINOIS! 529 DAY FREE COLLEGE SEMESTER SWEEPSTAKES ARE FULFILLED VIA THE COLLEGE ILLINOIS! MARKETING CAMPAIGN BUDGET.

- 1. ELIGIBILITY: COLLEGE ILLINOIS! 529 DAY FREE COLLEGE SEMESTER SWEEPSTAKES (hereinafter referred to as the "Promotion") is open to individuals who have are legal residents of Illinois counties who are at least 18 years of age as of the date of entry. Employees, officers, directors, and agents of College Illinois! ("Sponsor"), ISAC, the Jayne Agency, and their respective parent companies, affiliates, subsidiaries, sales representatives, wholesalers, distributors, printers, and advertising and promotion agencies and members of the immediate families (parent, child, sibling and their respective spouses, regardless of where they reside) and households of each, whether related or not related (collectively, the "Promotion Parties"), are not eligible to participate, be designated as a Beneficiary (as defined below) or eligible to use the Prize, whether such individual was a Promotion Party during the Promotion Period (as defined below) or a Promotion Party at the time the Prize (as defined below) is used.
- **2. HOW TO ENTER:** Promotion will take place from May 12, 2016 at 12:00 a.m. (CST) and will end on May 31, 2016 at 11:59 p.m. (CST) (the "Promotion Period"). During the Promotion Period, you may enter by going to collegeillinois.org/giveaway and by providing your first name, last name, and email address and hitting submit.

All entries must be received within the Promotional Period (each, an "Eligible Entry"). Limit of one entry per person. Duplicate entries or entries by one person using multiple email addresses may, at Sponsor's sole discretion, lead to disqualification of the duplicate entries or of the entrant completely. Participation in the Promotion constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions, which are final. Additionally, your submission of an entry constitutes your consent for the Sponsor to use certain identifying information in compliance with privacy laws, such as your name and e-mail address for the purpose of administering this Promotion.

**3. PRIZE:** One Eligible Entry will be randomly selected by College Illinois! representatives as the prize winner on or about June 3, 2016 (the "Potential Prize Winner"). The Prize Winner (as defined below) will receive the right to designate a person (the "Beneficiary") to receive A College Illinois! contract for one semester (15 credit hours) in the Community College plan, which covers 100% in-state, in-district tuition and mandatory fees at any Community College in the state of Illinois ("Prize"). The Prize Winner may designate himself or herself as the Beneficiary. Pursuant to the law governing the 4834-7253-4577.2

College Illinois! program, either the Owner of the College Illinois! contract or the Beneficiary must have been an Illinois resident for at least one year prior to the date of application to the program. Except as set forth in these Official Rules, the Prize cannot be transferred, exchanged or otherwise substituted for another prize or for cash or anything else of value by the Prize Winner or the Beneficiary. Sponsor reserves the right, at its sole discretion, to substitute a prize of equal or greater value. All federal, state, municipal and local taxes are solely Beneficiary's responsibility.

There is no age limit on the age of a Beneficiary; however, pursuant to the College Illinois! Disclosure Statement and Master Agreement there is a mandatory three-year waiting period before the Prize and any benefits related thereto can be used. That means that a Beneficiary will not be able to use the Prize or otherwise claim benefits until the fall of 2019, even if the Beneficiary enrolls in college prior to that time.

The current value of the Prize will depend on the age or grade level of the Beneficiary and ranges between \$2,022 for newborns to \$2,335 for ninth graders and above. No purchase is necessary to enter the Promotion or claim the Prize and there is no obligation to purchase a different plan or more semesters than those awarded as the Prize. Indicating that you will purchase more than the awarded semester or a different Plan will not affect eligibility or improve your chances of winning.
