## 2024-25 ECACE Scholarship Program

## **Program Overview**

- The program is intended for those who are currently working or have worked in early childhood education and are seeking additional credentials and/or a degree
- Must be attending a public or non-profit private 2- or 4-year Gateways-entitled and Early Childhood Access Consortium for Equity member institution as an undergraduate level student
- The scholarship may be used for any cost of attendance component, such as tuition, fees, room and board charges or commuter allowances
- Intended to be last payer, after other financial aid has been provided
- Recipients are expected to continue or return to teaching or direct services in the early childhood care and education field in Illinois after completion of their program of study
- Applicants are prioritized for awarding based on their Student Aid Index (SAI), from lowest to highest



## **ECACE Scholarship Program**

## What's New for 2024-25?

- The program is now funded by the State of Illinois rather than with federal funding
- Appropriation is \$5 million for Fiscal Year 2025 (2024-25 award year)
- The maximum annual award amount a student may receive is \$7,500
- Graduate students are not eligible for the scholarship
- ECACE will only be available for the regular school year terms (fall, winter and spring); it will not be available for the summer term



# **ECACE Eligibility Criteria**

To be eligible for the program an applicant must:

- Be a U.S. citizen or an eligible noncitizen or meet the undocumented student criteria of the RISE Act
- Be a member of the incumbent workforce, currently working or have worked in the early childhood industry (in either a licensed or licenseexempt facility), including home-based child care (e.g., family, friend, neighbor), center-/community-based care, Preschool for All programs, school-based preschool settings, and Head Start programs, that serve children from birth to age 5
  - Acceptable positions include teachers, assistant teachers, directors, family child care providers and assistants
  - Applicants be must be able to provide documentation confirming their current membership in the Gateways to Opportunity® Registry
- Be enrolled or accepted for enrollment on a full- or part-time (at least 3 credit hours) basis at the undergraduate level at an ECACE member institution



# **ECACE Eligibility Criteria**

To be eligible for the program an applicant must:

- Be pursuing at least one of the following:
  - An Associate of Applied Science degree (or related certificate) in early childhood education or an associate degree with a concentration in early childhood at an approved college; or
  - A bachelor's degree in early childhood education, with or without a Professional Educator License
- Maintain satisfactory academic progress as established by the college
- Complete the application process on or before the ISAC-established date in order to receive priority access to funding
- Be certified as meeting eligibility requirements by the college at which the scholarship will be used
- Not be in default on any student loan, nor owe a refund on any State or federal grant



# **ECACE Application Process**

- When available, the ECACE Application must be completed online through ISAC's Student Portal
- ISAC sends confirmation to the applicant's e-mail address when the application has been received
- Applicants must also complete a Free Application for Federal Student Aid (FAFSA<sup>®</sup>) or, if applicable, an Alternative Application for Illinois Financial Aid for the same academic year as the ECACE application
  - The ECACE participating college must be listed on the FAFSA®
  - The student must have a valid Student Aid Index (SAI)
- Students must reapply each academic year
- Due to limited funding, and the volume of applicants, **the 2024-25 ECACE** Application is no longer available
  - $_{\odot}\,$  The 2025-26 application will be made available much earlier than it was able to be provided for this year



# **ECACE Application Process**

## **Required Documentation**

- An applicant must:
  - Provide a Gateways Registry member ID number and current Registry membership dates
    - Membership must be current to qualify for the scholarship
  - Submit an Eligibility Verification Form from the Gateways Registry
    - Applicants must download and/or print the form and then upload when completing the ECACE application
  - Provide information about their employment in the early childhood field, using information from the Gateways to Opportunity Registry
    - The Eligibility Verification Form contains members' employment history, with assigned position codes

# After Completing the Application ...

- Applicants receive a confirmation e-mail when the ECACE application has been received by ISAC
- Different types letters are sent to indicate if the application is considered <u>timely</u> or <u>untimely</u>, depending on whether it was received at ISAC by the date for priority access to funding
- If an applicant needs to make a correction to their application, they will need to contact ISAC to provide the information
- Applicants must complete and submit both the ECACE application and the FAFSA (or, if applicable, Alternative Application) on or before the priority consideration date to be considered timely
- Colleges must certify student eligibility in ISAC's GAP Access system before awarding can take place
  - This process requires schools to indicate whether or not a student can be considered for an award based on eligibility criteria that must be confirmed by the school
    - For example: satisfactory academic progress, enrolled in an eligible program/degree, not in default on a student loan

#### Application Procedures for the Early Childhood Access Consortium for Equity Scholarship Program

When available each year, applicants may access the 2024-25 Early Childhood Access Consortium for Equily (ECACE) Scholanship Program interactive application via the Program Applications & Status Checks area of the ISAC Student Portal. The online application has built-in edits to prevent errors, and ISAC sends immediate confirmation to the applicati's e-mail address that the application has been received.

An ECACE Scholarship application, listing the student's college of record, must be submitted for each academic year in which benefits are to be used. Applicants are also required to complete the Free Application for Federal Student Aid (FAFSA®) or, if applicable, an Alternative Application for Hinois Financial Aid (Alternative Application) for the same academic year that they are applying for the scholarship. # 2024-25 ECACE

## What's Currently Happening? Student Awards

- Colleges have completed the certification process for timely renewal applicants and awarding was done on Monday, September 24
- Awarding prioritization was based on:
  - An applicant's renewal status
    - Renewal status means that the student was paid ECACE Scholarship benefits in the previous 2023-24 award year
  - The application receipt date
  - The applicant's Student Aid Index (SAI)
    - Awarding to those with the lowest (-1500) SAIs
- All 2024-25 ECACE Scholarships were awarded to timely renewal applicants with an SAI of -1500
  - Funding was not sufficient to award to all applicants who meet this criteria
- Colleges are now able to submit payment requests to ISAC on behalf of students who have been awarded a scholarship



# 2024-25 ECACE

## What's Currently Happening? Notifications and Communication

- Students are being sent notifications from ISAC regarding their award
  - A Notice of Insufficient Funding will also be sent to eligible students unable to receive an award due to funding limitations
- An e-message with details about awarding and payment processing has been sent to financial aid administrators at the colleges
  - In addition, ISAC has sent a letter to college presidents, chancellors, and chief student service officers encouraging institutions to exercise flexibility to protect those students who may not have received an ECACE scholarship from academic or financial penalties
  - A sample of the letter is available via the ECACE e-message that was sent to the colleges



# **ECACE Q and As**

Can a student receive an ECACE Scholarship and an MTI, Golden Apple or SETTW scholarship in the same academic year?

A student may receive both an ECACE Scholarship and either an MTI, Golden Apple or SETTW benefit during the same academic year. A student cannot receive benefits from MTI, Golden Apple and SETTW in the same year. A student may only receive one of those ISAC teacher programs in an academic year, and one of those may be combined with an ECACE Scholarship. In those cases, the ECACE Scholarship is intended to be the last payer after assistance from the other ISAC program has been provided.

Can a student receive the Gateways Opportunity Scholarship or Chicago Early Learning Workforce Scholarship concurrent with the ECACE Scholarship?

Receiving additional non-ISAC administered scholarships, institutional aid or other private forms of assistance will not prevent a student from receiving an ECACE Scholarship if eligible and awarded.



# ECACE Q & As

Can a student who has just completed their AA/AAS degree continue to receive an ECACE award to complete their bachelor's degree?

Yes, this student would still be considered an undergraduate student and would be eligible to receive an ECACE Scholarship. For 2024-25, eligible degrees include an AA/AAS and bachelor's degree in Early Childhood Education.

Does the post-baccalaureate exclusion prevent someone with a bachelor's degree in a different field from receiving an award if they go back to school to get an AA/AAS or BA/BS in Early Childhood Education to work in this field (i.e., a career-changer)?

No, the post-baccalaureate exclusion does not prevent a student from applying for the ECACE Scholarship if they are enrolled or accepted for enrollment in a program that will lead to an AA/AAS or bachelor's degree in Early Childhood Education.

# **ISAC Gift Assistance Programs**

## Monetary Award Program (MAP)

- Eligibility is based on financial need
- Covers tuition and mandatory fees at MAP-approved institutions
- o 2024-25 maximum annual award is \$8,400
- The Free Application for Federal Student Aid (FAFSA) and the Alternative Application for Illinois Financial Aid (for eligible undocumented students) are the applications for this program

## AIM HIGH Grant

- $_{\circ}~$  Awarded to students at the 12 Illinois public universities.
- Eligibility is based on financial need and other requirements established by each university.
- Provides renewal grant assistance toward a full-time undergraduate student's cost of attendance at the university



# **ISAC Gift Assistance Programs**

- Grant Programs for Dependents of Police, Fire, and Correctional Officers
  - For spouse and children of Illinois Police, Fire or Correctional Officers killed in the line of duty
  - Provides assistance for tuition and mandatory fees
  - October 1 application deadline for full-year consideration
- Displaced Energy Worker Dependent Transition Scholarship
  - Intended for children of energy workers who lost employment due to reduced operations or closure of a fossil fuel power plant or coal mine
  - Pays tuition and fee costs at public universities or community colleges for a period equal to one calendar year, including a summer term, for undergraduate or graduate study
  - October 1 application deadline for full-year consideration



# **ISAC Teacher Programs**

## Minority Teachers of Illinois Scholarship Program

- Encourages academically talented minority students and/or qualified bilingual minority students to pursue careers as teachers at non-profit Illinois preschool, elementary and secondary schools
- Maximum award amount is up to \$7,500 per year
- $_{\circ}~$  Can be used for tuition, fees, room and board or commuter charges
- Golden Apple Scholars of Illinois Scholarship Program
  - Encourages academically talented Illinois students, especially minority students, to pursue teaching careers, at high-need, hard-to-staff schools
  - Scholars qualify for up to \$2,500 or \$5,000, depending on the year in the program
- Special Education Teacher Tuition Waiver Program
  - Purpose is to encourage current teachers and academically talented students to pursue careers in the area of Special Education
  - Exempts recipients from the payment of tuition and mandatory fees for up to four calendar years at any of the public universities in Illinois
  - $_{\circ}~$  ISAC awards 250 waivers annually

## • Illinois National Guard (ING) Grant


- Eligible applicants are exempt from paying eligible tuition and certain fees
- Benefits are available at all Illinois 4-year public universities and public community colleges
- May be used at the undergraduate and graduate levels

## • Illinois Veteran Grant (IVG)

- Eligible applicants are exempt from paying tuition and mandatory fees
- Benefits are available at all Illinois 4-year public universities and public community colleges
- May be used at the undergraduate and graduate levels

There are probably a lot of things you're wondering about, like what you'll need to do to be certified to teach, what salaries teachers make, how you can pay for college and others. The academic advisor at the college you're planning to attend can also counsel you about which classes to take to prepare you for your teaching career.

#### **Teacher Preparation and Certification**

Before you decide to enter the teaching profession, take advantage of the information provided by the Illinois Career Information System - overviews of different teaching fields, including course planning, employment outlook, working condition and wages. You can also access tools available via the Resources area of the ISAC Student Portal – including Cappex and the U.S. Department of Education's College Scorecard – to help you locate Illinois colleges that offer degrees in education. Additionally, the Illinois State Board of Education (ISBE) Division of Educator Licensure website provides the testing requirements to be certified to teach in Illinois, testing preparation and other valuable information about becoming a teacher.

#### Monetary Award Program (MAP)

Who's Eligible: Illinois undergraduates at approved Illinois public and private 2- and 4-year colleges, hospital schools, and other degreegranting institutions. Eligibility is based on financial need. Apply as early as possible using the Free Application for Federal Student Aid (FAFSA®), or, if you are a gualifying undocumented student, the Alternative Application for Illinois Financial Aid.

Amount: Tuition and fees, up to \$8,400 per year

#### AIM HIGH Grant

Who's Eligible: Illinois undergraduate students at the 12 Illinois public universities. Eligibility is based on financial need and other requirements established by each university. Contact the financial aid office of the university you plan to attend to learn about any additional benefits and requirements.

Amount: Tuition and fees and room and board up to \$7,500 per year







# **Gateways Scholarship Program**

## • Helps pay for...

- Gateways Credential
- Associate, bachelor's or master's degrees in early childhood and/or Child Development
- Courses toward a Professional Educator License with an endorsement in Early Childhood,
- Courses toward an ESL/Bilingual endorsement
- Courses to advance on the Great START wage supplement scale

## • Who can apply?

- In IDCFS licensed programs: Family Child Care Provider, Family Child Care Assistant, Group Home Provider, Group Home Assistant, Director, Assistant Director, Teacher, Assistant Teacher, School-Age Teacher, School-Age Assistant
- In an ISBE Funded Preschool for All (PFA) program that operates for a minimum of nine months per year: Teacher or Teacher's Aide.

# **Eligibility Requirements**

- Illinois Department of Children and Family Services (IDCFS) Licensed Program
  - Working in a full day, full year DCFS licensed childcare program.
    - A full day, full year program is one that operates 47 weeks per year, serving children 8 hours per day.
  - Working a minimum of 15 hours per week
  - Working at CURRENT place of employment for minimum of one year (or 90 days if you work for a program holding an ExceleRate Illinois Circle of Quality)
  - Meeting wage requirements

## • Illinois State Board of Education (ISBE) Funded PFA

- Working in current program for one full school year
- Working a minimum of 15 hours per week
- Meeting wage requirements

## GOALS

City agencies collaborated to launch the Chicago Early Learning Workforce Scholarship (CELWS) initiative in 2018.





- CELWS aims to support Chicagoans and the current Chicago Early Learning workforce as they pursue coursework to earn a credential, degree, endorsement, or licensure to work with young children (birth through Pre-k) and families in Chicago Early Learning programs.
- The scholarship serves an important role in Chicago's efforts to expand access to early learning across the city and build a more robust workforce that can help Chicago expand high quality early learning programs.
- CELWS provides recipients with meaningful career pathways through partnerships with Institutions of Higher Education, which also offer students personalized supports as they navigate their desired course of study.

# CHICAGO EARLY LEARNING WORKFORCE SCHOLARSHIP

- <u>How to Apply</u>: Mid-January to February, applications can be completed on the *Chicago Early Learning* website. Once complete, the applicant will receive follow-up from Screening team (INCCRRA).
- <u>Amount</u>: The scholarship will serve as a "last dollar" scholarship, meaning it will cover everything that students' federal grants and other scholarships do not cover.
  - Tuition & eligible fees at 100%
  - Books up to \$250/course
- <u>3-year work commitment</u>: Chicago Early Learning Workforce Scholarship recipients must commit to work in a Chicago Early Learning (CEL) Program (Community-based organization or CPS birth through Pre-K program) for a minimum of three years after completion of their degree or approved academic program.




- Q:When do I apply for a Chicago Early Learning Workforce Scholarship?
- A: Applications open in mid-January every year
- Q: How long may I participate in the Chicago Early Learning Workforce Scholarship program?
- A: CELWS will support awardees through Academic program/Degree attainment, contingent on funding, as long as students meet following requirements:
  - Maintain Good Standing and Continued Enrollment at your selected college/university
  - Earn a GPA of 2.0 or higher
  - Commit to work in a birth through Pre-K Chicago Early Learning Program (community-based organization or Chicago Public School) for three years after completion of the academic program or degree
- Q: How many credits can I be registered for?
- A: Maximum of 15 semester hours or 23 quarter hours per term


