## SSP Sixth Semester Academic Information Request Instructions and Reminders

Some reasons a student would be added to the *Sixth Semester Academic Information Request* form include:

- a student who ranks in the top 50% of the class as of the sixth semester (i.e., as of June 30, 2024), but does not appear on the *SSP Sixth Semester SSP Student List Eligibility* screen (student listed the wrong school code on test);
- a student whose test results include an invalid graduation date and/or invalid grade level.

Reporting a duplicate record:

- a student appears as a duplicate record on the *SSP Student List Eligibility* screen (i.e., student provided different name, date of birth (DOB) on multiple tests).

All academic information provided must be based on sixth semester data as of June 30, 2024. The sixth semester is defined as the third semester prior to graduation.

Provide all of the required information on page 1 of this *SSP Sixth Semester Academic Information Request* form.

- Provide a student's name, address, and birthdate. **List students alphabetically by last name.**
- For schools that do not rank, provide an **Unweighted GPA**. Weighted GPAs cannot be accepted.
- Test Score and Test Date – Provide the student's highest test score and test date from the ACT and SAT exams taken **between August 1, 2023 and June 30, 2024**, as well as a copy of the Score Report for each student's highest test score.
- If a duplicate record displays on the *SSP Student List Eligibility* screen (i.e., student provided different name or DOB on multiple tests), provide the correct name, address, and DOB, then indicate "Y" in the "Duplicate Record Column".
